I the undersigned practicing Advocate, R.T.I. Activist and Social Worker appreciate and thank your good offices for acknowledging my earlier letter dated nil, duly acknowledged by your good offices on 09.09.2020.

At the same time I am also very much regretted to lodge my protest for not (sic) initiating any action against your alleged employee **Mr. Ratan Mahadik** R/o. Flat No.34, A-Wing TAKSHILA Building No.25 CHS Ltd., Vallabhai Patel Road, Off. Mahadik, Ch. Road, Andheri (East), Mumbai

400093 (impersonating/ Claiming himself to be a Vigilance Officer serving in your office of Mumbai Port Trust without displaying/showing his Identity Card in our complex) doing brokerage business in our Takshila Complex and/or providing the information as sought for in my earlier soft copy letter dated nil sent by mail and duly acknowledged by your good office on 09.09.2020.

Sirs, the inadvertent inordinate delay in furnishing the information by your good offices, as sought for by me on behalf of boanfide resident members of our Takshila Complex to make our various cases filed against Mr. Ratan Mahadik in M.I.D.C. Police Station stronger, has emboldened him to such an extent that he still continue to do his illegal brokerage business with his boasting that no authority including your good offices can initiate any action against him as all the concerned authorities are being managed by him by his ill gotten money. He also continue to threaten me and some of the members in abusive language of dire consequence and/or implicating us in false Cases of Atrocity etc. by using the name/influence of Union Minister Mr. Nitin Gadkari who he alleges to be very close to him.

Sir, at least now in order to restrain Mr. Ratan Mahadik from continuing to impersonate and/or claim himself to be a Vigilance Officer serving in your office of Mumbai Port Trust without displaying/showing his Identity Card with a view to carry on his illegal brokerage business in our Takshila Complex and avoid any untoward incidence and bring him to his senses and, it has now become utmost necessary to either procure the information along with the documents as requested for by me, from your good office at the earliest to submit the same in M.I.D.C. Police Station to

make our various cases of cognizable offences filed against Mr. Ratan Mahadik stronger and/or make humble request once again before your good offices to initiate action against your alleged employee **Mr. Ratan Mahadik** (impersonating/ Claiming himself to be a Vigilance Officer serving in your office of Mumbai Port Trust without displaying/showing his Identity Card) doing brokerage business in our Takshila Complex in the interest of justice.

Trusting that all the above addressed dignitaries will consider our this humble request of seeking the information/documents as sought for by us in the interest of Justice and oblige us.

I the undersigned Advocate practicing in the Hon'ble High Court of Bombay since last about 20 years and R/o. 19-B/3, TAKSHILA, Vallabhai Patel Road, Off. Mahakavi Caves Road, Andheri (East), Mumbai - 400093 through my this humble letter wish seek some information regarding one **Mr. Ratan Mahadik** R/o. Takshila Bldg. No. 25 A/34 (*impersonating/Claiming himself as Vigilance Officer serving in your office of Mumbai Port Trust without displaying/showing his Identity Card*) doing brokerage business in our Takshila Complex. The brief facts giving rise to seeking his information through this letter is as under:

Sir, initially on **23.06.2020** a legal notice was addressed to the MIDC Police Station, Andheri (East) on behalf and on instructions of one Postman Mr. Nitesh Siddharth Mohite for trying to restrict the entry of his father Mr. Siddharth Shivram Mohite (*working as Watchman in Takshila Bldg. No.25 CHS Ltd.*) into our complex by Mr. Ratan Mahadik (*impersonating/Claiming himself as Vigilance Officer serving in your office of Mumbai Port Trust*) by citing/discriminating Mr. Siddharth Mohite to be carrier of Covid 19 without any documentary evidence/certificate from any competent authority, for being resident of slum for his sadistic pleasure. The same was then put up on Society's notice board by me to bring it to the kind notice of all the bonafide resident members of our complex after making requisite payment for Five days to the Society.

Just a week before I filed the Complaint cum legal notice dated 23.06.2020, the said Mr. Ratan Mahadik along with one Mr. Sriram Singh who also claim to be Government Servant and having business relation with Union Minister Mr. Nitin Gadkari with a view to fulfill their ulterior motive of removing the Authorized Officer Mr. R.G. Redekar him from the said post by defaming, maligning his image had lodged a joint false complaint dated **18.06.2020** in the MIDC Police Station falsely alleging of making money by selling wood in connivance with BMC Engineer/Contractor without any documentary or other proofs. The Authorized Officer then submitted his statement to the MIDC Police Station vide his reply dated **07.07.2020** denying all their false allegations in toto with a special mention that in case in future any untoward incident occurs due to non trimming/cutting of branches of dangerous trees as surveyed and identified by the Tree Authority of the MCGM, then the aforesaid both Mr. Mr. Ratan Mahadik and Mr. Sriram Singh should/will be held responsible for the same.

When the said Mr. Ratan Mahadik (*impersonating/Claiming himself as Vigilance Officer serving in your office of Mumbai Port Trust*) came to know about the legal notice posted on the Society's Notice Board, he then tried to pressurize the same Mr. R.G. Redekar, against whom Mr. Ratan Mahadik & Mr. Shriram Singh had filed joint False Police Complaint through various ways. After failing to pressurize Mr. R.G. Redekar, Mr. Ratan Mahadik then approached our erstwhile Chairman Mr. Shrikant Kotian with a request to persuade me to remove the said legal notice dated 23.06.2020 addressed to the MIDC Police Station posted on the Society's Notice Board by handing over the copy of the apology cum withdrawal letter dated **28.06.2020** thereby withdrawing the false complaint dated **18.06.2020** with false allegation lodged against the Authorized Officer and the BMC Contractor.

The apology cum withdrawal letter dated 28.06.2020 was in fact Voluntary admission made by Mr. Ratan Mahadik which is reiterated by me in English and Marathi by Translating as under quote "*I the undersigned Mr. Ratan Mahadik R/o.*

vided by Mr. Shriram Singh. Accordingly I hereby withdraw the complaint made against Mr. Redekar & the Contractor. Since I did not like the id [redacted]. Shriram Singh given to me for falsely implicating the erstwhile Bhadra Members, I repent for the mental agony caused to Mr. Redekar and also to the damage caused to his reputation in his Co-operation Department and I therefore withdraw my complaint".

Then when Mr. Ratan Mahadik learnt that I did not accede to the request made by our erstwhile Chairman, he then threatened me in abusive language of dire consequence and/or implicating me and other erstwhile office bearers of Bhadra CHS Ltd., in false Cases of Atrocity etc. if I did not withdrew the said legal notice dated **23.06.2020** addressed to the MIDC Police Station on instructions and on behalf of my client Mr. Mr. Nitesh Siddharth Mohite, son of Mr. Siddharth Shivram Mohite (*working as Watchman in his Takshila Bldg. No.25 CHS Ltd.*). Despite his threatening I continued to pursue the said legal notice and other complaint lodged against the said Mr. Ratan Mahadik in MIDC Police Station resulting into recording of my Statement and lodging of Complaint against the said Mr. Ratan Mahadik.

The unintentional delay in taking any concrete action by the Police authorities against the said Mr. Ratan Mahadik due to their stressful duties during Covid 19 Corona Virus Pandemic has embolden him further to harass and commit more discriminatory act against the poor malis, gutter cleaners security personnel, etc., which compelled the Security Supervisor Mr. Nagraj kamat to lodge detailed Complaint dated 01.07.2020 against Mr. Ratan Mahadik. It is also learnt that besides indulging in Cheating the parties, manipulation/fabricating/forging of Share Certificates/Letter Heads of our various Takshila Building Societies for NOC etc. he has forged the Documents including Share Certificate pertaining to Flat No.1 in A-Wing of his Takshila Bldg. No.25 CHS Ltd. (*where he presently resides*) belonging to one Late Dr. Vijayalaxmi Ray and her Late husband who have died intestate and issueless, with a view to usurp the said flat for his self gain.

When all the erstwhile co-opted Care Taking Committee Members of Bhadra CHS Ltd. including me being the Legal Advisor of Bhadra CHS Ltd. learnt about their ulterior motive of deliberately trying to implicate us in the alleged mass tree trimming matter though we were/are not at all concerned in any way with the said matter, we immediately drafted detailed complaint addressed to Senior Inspector of Police, MIDC Police Station, Andheri (East) with a request to initiate action against the said Mr. Ratan Mahadik by lodging the FIR, which is in process. Now with a view to make our case stronger we wish to seek some more information from your office as under;

a) Kindly arrange to furnish the detailed information along with appointment letter and Identity Card if any issued to him by your Department with regard to the appointment of Mr. Ratan Mahadik as Vigilance Officer in the Mumbai Port Trust (*as Claimed, boasted and is being impersonated by Mr. Ratan Mahadik in our complex*).

b) Kindly arrange to furnish the copy of the written permission issued, if any to Mr. Ratan Mahadik to carry out the Brokerage Business in our and also the permission to Work (of Vigilance) from Home by

exempting his personal attendance in your office during this Covid-19 Corona Virus Pandemic.

c) Kindly also arrange to furnish the copy of G.R., Notification, Circular, Order issued in general if any to allow the Employees of your Mumbai Port Trust to carry out the Brokerage Business in their Housing Complex during the office hours or while in service being (Government Servant).

d) In the alternative kindly arrange to furnish the Copy of G.R., Notification, Circular, Order issued if any by your department with regard to his Voluntary Retirement, Suspension, Dismissal and/or Retirement on Superannuation.

Sir lastly it is once again humbly requested on behalf of myself, erstwhile Care Taking Committee Members and other bonafide resident members of Bhadra CHS Ltd. to kindly consider our this humble request and arrange to provide the information as sought for to restrain him from doing illegal work as mentioned above, in the interest of all the bonafide resident members of our Complex and Justice.

Trusting that you all the dignitaries will consider our this humble request and oblige.

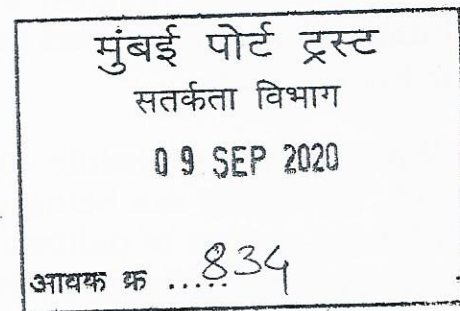

boundary wall and building roads till Goni Nagar Slums by MHADA & B.M.C. in connivance with our local M.L.A. & Municipal Corporator, which is likely to disturb the peace and tranquility of the complex and continuing his brokerage business in the name & style of M/s. (Sic) Saroj Estate in our Takshila Complex. This fact can also be verified and confirmed from one of the notice put up by Mr. Ratan Mahadik on the Notice Board of our Apex Body viz. Bhadra CHS Ltd. recently on 31.01.2021, by paying the requisite fees of Rs.300/- per day.

5) Hence in order to prove the incessant boasting of Mr. Ratan Mahadik that **"no authority including your good offices can initiate any action against him as all the concerned authorities are being managed by him by his ill gotten money", and further suspect that as boasted by him all his illegal acts are also being shielded by some of the officials for the reasons best known to them.**" wrong and further to verify and confirm that Mr. Ratan Mahadik is really exempted from his personal attendance and allowed to work from home during office hours by his superiors of Materials management Division of Mechanical and Electrical Engineering Department of your Mumbai Port Trust, all the Hon'ble dignitaries are hereby once again humbly requested to kindly look into the matter personally and arrange to direct the concerned establishment section and/or the Materials Manager of Materials management Division of Mechanical and Electrical Engineering Department to kindly furnish the true and full detailed information, (besides the information sought for in clause (b) & (c) of our earlier communication dated 09.09.2020 & 11.01.2021) without suppressing anything in the interest of justice as under;

a) Regular Office Duty hours with shift duty hours, if any, to be observed by the employees (Classified and Unclassified) of Materials management Division of Mechanical and Electrical Engineering Department of your Mumbai Port Trust before the spread of Covid 19 Corona Virus Pandemic till March 2020.

b) Resolution/Notification/Circular if any issued exempting personal attendance of the employees (Classified and non-classified) of Materials management Division of Mechanical and Electrical Engineering Department of your Mumbai Port Trust after the spread of Covid 19 Corona Virus Pandemic since March 2020.

c) Regular Office Duty Hours Chart with Duty Timings of the employees (classified and non-classified) serving in Materials management Division of Mechanical and Electrical Engineering Department of your Mumbai Port Trust where Mr. Ratan Mahadik is serving as Senior Assistant.

d) Details of Office Duty hours timings allotted to Mr. Ratan Mahadik, Senior Assistant for the month of January & February, 2021 and specifically on 27.01.2021 & 01/02.02.2021.

6) Lastly it is also once again further humbly requested to kindly direct your

Ratan Mahadik during the office hours to knock out his false boasting of keeping his higher officials in his pocket by his ill gotten money and restrain Mr. Ratan Mahadik from further harming the reputation of your Mumbai Port Trust in Public places by continuing his brokerage business during the office hours without valid, legal permission being Government Official working under the Ministry of Ports.

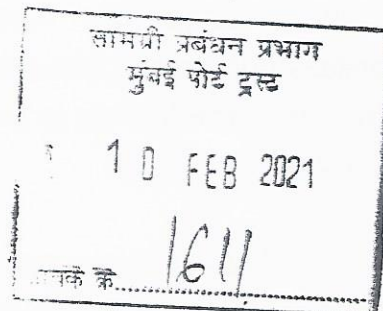

Respected Madam/Sirs,

1) This is in furtherance to my earlier communication dated 11.01.2021 made with Materials Manager and copy forwarded to you all above dignitaries after the receipt of partial information on 08.01.2021 addressed reluctantly by the Materials Manager for the reasons best known to him/her.

2) Sirs, despite the lapse of about one month, the Materials Manager, directed/authorized, if any, by above dignitaries to furnish the true and full detailed information as specifically sought for on behalf of my clients, in clause (b) & (c) of our earlier communication dated 09.09.2020 & 11.01.2021 has completely failed and neglected to furnish the information till addressing/making of this present reminder request being made by us.

3) It is significant to point out at this juncture that the said information was specifically sought by us to verify and confirm as to whether Mr. Ratan Mahadik was/is really exempted from his personal attendance during office hours and work from home during period i.e. on the said date of incidences occurred in June 2020 or the misconduct of remaining absent without authorization was/is being intentionally shielded by the concerned officials of the Materials management Division of Mechanical and Electrical Engineering Department of your Mumbai Port Trust by marking him present and working on the said date of incidences and the present dates viz. (27.01.2021 at about 11.30 A.M. when he was seen instigating one of the gullible resident members by spreading rumors of demolishing our boundary wall and building roads till Goni Nagar Slums by MHADA & 01/02 .02.2021 at about 12.15 Hrs when he was seen showing flats to some prospective licensees/purchasers without making entries in the main gate), for the consideration other than the law as is being continuously boasted by Mr. Ratan Mahadik in the Complex.

4) This is because if he has not been permitted to work from home by exempting his personal attendance during office hours, then how come he is personally seen at least thrice in a week during the office hours i.e. between

*c) *Kindly also arrange to furnish the copy of G.R., Notification, Circular, Order issued in general if any to allow the Employees of your Mumbai Port Trust to carry out the Brokerage Business in their Housing Complex during the office hours or while in service being (Government Servant).

*d) *In the alternative kindly arrange to furnish the Copy of G.R., Notification, Circular, Order issued if any by your department with regard to his Voluntary Retirement, Suspension, Dismissal and/or Retirement on Superannuation*."*

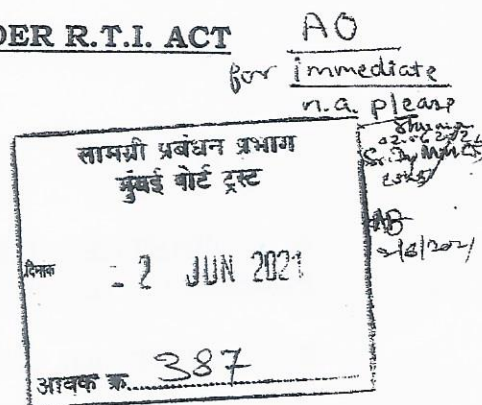


