- २) (i) दिनांक १०.०९.२०१७ रोजी माझ्या वयोवृद्ध आई व माझ्यावर माझ्या पत्नी व मुलाने जीवघेणे मारहाण करुन रात्रीच्यावेळेस घरातून हाकलून दिलेले होते. 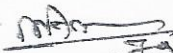

15. Introduction of incentives among S.P.T. employees for promoting the small family norm.

Secretary's note dated 21st August 1980 as follows:

Orders issued by the Central Government to provide incentive to promote the small family norm among the Central Government servants are contained in the Ministry of Finance (Department of Expenditure) O.M.No.7(39)-EIII/79 dated 4th December 1979. Copy of the orders are attached.*

2. Central Government employees undergoing sterilisation after having two or three surviving children have been granted a special increment in the form of personal pay with effect from 4-12-1979. The increment is not absorbed in future increase in pay either in the same post or on promotion to higher posts. The rate of personal pay will be equal to the amount of the next increment due at the time of grant of the concession and will remain fixed during the entire service. In the case of persons drawing pay at the maximum of the pay scale, the rate of personal pay will be equal to the amount of the increment last drawn. The grant of the concession is subject to the conditions laid down in the orders.

3. The incentive scheme at present applicable to BPT employees undergoing sterilization, vide T.R.No.233 of 1979, provides for cash awards as under :

If an employee who has already availed the benefit of the incentive money, he/she will be granted the special increment and the cash award already paid will be recovered. However, he/she will be allowed to retain the State Government's share so long as that Government permits payment of their share.

5. The Chief Medical Officer has also proposed that since the above scheme will not apply to employees having more than three children, the scheme of cash award, referred to in para.3 will be retained for them. So far the State Government has not withdrawn their share in this scheme. In case it is decided by the State Government to withdraw their share, SPT should continue to pay the amount equivalent to that share so that the amount of cash award is not reduced.

6. Sanction of the Board, subject, in so far as it applies to employees referred to in section 24(1)(a), to the sanction of Government, is requested to the Chief Medical Officer's proposals, as set out in paragraph 4 above.

Note of discussion at the Board meeting held on 27th Oct 1980.

In reply to a query from Shri D.K. Jain, the Chairman explained that the proposal envisaged grant of a personal pay provided the prescribed conditions were fulfilled. The view taken so far was that under section 23 of the Major Port Trusts Act, the Board was competent to sanction the personal pay. Government's sanction under that section would be required only in respect of employees referred to in section 24(1)(a) of the Act. In previous such cases Government's sanction had been sought and accorded only in so far as they affected the employees referred to in section 24(1)(a) of the Act. Sanction of Government would be required only for formal regulations framed under section 28 of the Act.

Shri D.K. Jain stated that while the proposal might be approved, it might be separately examined whether formal regulations were required to be framed and if it was found that they were so required, necessary action taken with the sanction of the Board and Government.

The Chairman agreed with Shri Jain's suggestion.
