Sub : Instructions regarding checking of
car Carriers by CISF.

Asstt. Commandant, CISF Unit MbPT vide their letter No. IC-42099/CISF /MbPT/INT/2018-1929 dated 27.04.2018 has informed that car carriers loaded with cars/vehicles for export enters through OGPD regularly and after unloading of cars in the designated areas of the port, the empty car-carriers are exiting through OGPD. It is informed that while checking of outgoing empty car-carriers by CISF personnel at OGPD, inconvenience is being experienced for checking the upper deck of the car carriers due to more height and from the back window of the car carriers only basement section can be checked easily. Hence, they have requested to inform all concerned automobile carriers to instruct their drivers/operators of car carriers to make deck convenient for checking by putting it down to the desirable level positively.

You are requested to comply with the instructions of CISF and do the needful.
