Vide Circular dated 18.11.2016 referred to above, procedure for registration / renewal of licenses for Users and ancillary trade at New Fish Jetty, Ferry Wharf and New Sassoon Fish Harbour & Old Sassoon Dock was laid down.

Further, due to persistent demand from Vehicle/ Transport Owners and their Associations, it has been decided to issue fresh licenses on payment of MbPT charges for all types of Vehicles / Transport at New Fish Jetty, Ferry Wharf and New Sassoon Fish Harbour & Old Sassoon Dock, related to fish handling activities.

In view of above, fresh applications are invited from all applicants intending to obtain licenses for Vehicles/ Transports on '**First Come First Served**' basis subject to submission of documents viz.

- (i) Application for licence in the prescribed format with self-attested recent Passport size photograph.
- (ii) Self attested copy of Aadhar Card or any other photo identity card recognized by Govt.
- (iii) Valid self-attested copies of R.C. book and Insurance of truck/ tempo/ tanker, etc.
- (iv) Payment of MbPT Licence fees.
- (v) Acceptance of terms and conditions mentioned in Licence Booklet.

You are requested to give wide publicity amongst your members to avail of the facility.
