Sub : Registration with Maharashtra Fishing Industries
Labour Board for fishermen and other manual workers
(Regulation of Employment & Welfare)

All the individual owners / firms who are engaged in fisheries or other allied business at Sassoon Dock are hereby informed that Maharashtra Government has formed a Board viz. "Maharashtra Fishing Industries Labour Board for fishermen and other manual workers (Regulation of Employment & Welfare)" from 2014 for various activities pertaining to fisheries business such as catching / discharging / loading/ cleaning / peeling / storage / weighing / drying, etc. The aforementioned scheme is applicable to all aforementioned business owners and workers operating at Sassoon Dock in fisheries and other allied businesses.

2. All the aforementioned owners are required to register their workers engaged by them on daily/ monthly/ temporary / permanent basis with "Maharashtra Fishing Industries Labour Board for fishermen and other manual workers (Regulation of Employment & Welfare)".
3. The registration with Maharashtra Fishing Industries Labour Board for fishermen and other manual workers (Regulation of Employment & Welfare Scheme 2014) is mandatory to comply with the provisions of Maharashtra Mathadi Hammal & other manual workers (Regulation of Employment & Welfare) Act, 1969.
4. In view of above, you are requested to prevail upon your members to register all the persons / firms engaged in fisheries or other allied trade / business by immediately contacting officials of "Maharashtra Fishing Industries Labour Board for fishermen and other manual workers (Regulation of Employment & Welfare Scheme 2014)".
5. Please note that all the owners / firms who enrol/ register themselves with the Scheme formulated by Maharashtra Government for fishermen and other manual workers shall not directly disburse the wages payable to their workers but shall deposit the wages and 30% applicable cess with the Board.
