(i) Application for licence in the prescribed format with all attested recent passport size photograph, (ii) self attested copy of Aadhar card or any other photo identity card identified by Govt., (iii) acceptance of terms and conditions mentioned in the Licence Booklet, (iv) payment of MbPT licence fee as per Section 6.1 (B)(3) of Scale of Rates, (v) Self attested copy of Handcart plying licence issued by Municipal Corporation of Greater Mumbai (MCGM) as mentioned in Circular dated 18.11.2016.

You are requested to give wide publicity amongst your members to avail of the facility.
