<p>Educational Qualification and Experience :</p> <p><u>Essential</u></p> <p>(i) Radar Plotter Grade-1 Certificate holder from Indian Navy or Coastguard (Retired).</p> <p>(ii) Proficiency in Computers and computer language.</p> <p>(iii) One year experience on sailing ship as Radar Plotter.</p> <p><u>Desirable</u></p> <p>Previous VTS or Radar Plotter/port operations experience will be preferred.</p>	<p>Work profile :</p> <p>Candidate will be required to attend all the work related to VTS Operator/Data Entry/Shipping Assistant and any other work as directed by the Dy. Conservator.</p>

2. Number of posts may increase or decrease as per the requirement.
3. **Age limit : 40-55** years on the date for submission of application.
4. **Remuneration, benefits and terms and conditions for appointment:**
 - (i) Duration of contract : The contract shall be initially for a period of one year from the date of engagement, extendable by one year at a time, at the discretion of MbPA.
 - (ii) Medical fitness from MbPA Hospital is compulsory before joining.
 - (iii) Selected candidate shall be paid a consolidated remuneration of Rs.50,000/- (per month). No other allowances or benefits would be admissible.

- (iv) Duty Hours : Working pattern will be 24 hours on / off or 12 hours on/ off with weekly off as per work requirement. If situation warrants, the weekly day of rest may be changed with prior intimation.
- (v) Leave entitlement - Casual leave of twelve days in a year only is admissible, which shall be availed with prior approval.. For any absence in excess of 12 days, pro-rata deduction will be made from the consolidated remuneration. Casual leave will be adjusted proportionately in case of shorter period of engagement.
- (vi) Accommodation- If desired, Mumbai Port Authority accommodation as admissible will be provided, as per availability and on recovery of rent at 25 times the prescribed license fee for the unit allotted alongwith the electricity charges and water charges on consumption basis.
- (vii) Medical facility- No medical facilities would be available to the candidate and his family.
- (viii) The contract can be terminated by giving one month notice in writing from either side. If the candidate leaves without notice or acceptance of notice of termination, the amount due to him, consolidated remuneration payable to the extent of notice period will be forfeited. However, the engagement is terminable on 24 hour notice, for unsatisfactory performance and for any act that is considered detrimental to the interest of the Port.
- (ix) On completion of contract and if there is no further renewal then accommodation allotted to the candidate is to be vacated within one month.
- (x) The candidate shall be responsible for the charge and care of the Mumbai Port Authority goods, stores and other properties that may be entrusted to him/her and will be accountable for the same.
- (xi) The candidate will not have any claim/right whatsoever for regular appointment/absorption in Mumbai Port Authority under any circumstances.

5. **General :**

- (i) Applications may be submitted in the **prescribed form** which may be downloaded.

- (ii) Applicants already in service of Government/ Semi-Government Organisations/ Public Sector Undertakings/ Autonomous Bodies must apply **through proper channel**.
- (iii) Applicants may attach self certified copies of certificates/documents in support of essential qualifications with their application.

Desirous candidates may visit office of Dy. Conservator/Harbour Master between **15.00 hours and 16.00 hours** on any working day.
