2. Accordingly, assistance of the concerned office of the Traffic Department has been sought as per the provisions under Section 5(4) of the RTI Act, 2005.

3. The details required by you, relates to the personal information of Shri. Prakash Bhagaji Padale, under the provisions of Section 8 (1)(j) of RTI Act. Therefore, as per provision in section 11 of RTI Act, 2005 consent of Shri. Prakash Bhagaji Padale, was sought vide this office letter No. TM/M/13-5/RTI/197/28/887 of 2023-24 dated 01.11.2023. Shri. Prakash Bhagaji Padale, vide his letter dated 16.11.2023 has requested this CPIO **not to provide** the information.

4. The information sought as date of appointment, date of retirement, retirement dues of PF, Gratuity, Pension, his mobile no., residential address and aadhar card no, etc. is being personal information, exempted from disclosure under Section 8 (1)(j) of RTI Act, 2005.

Section 8 (1)(j) of RTI Act, 2005 read as under:-

"information which relates to personal information, the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the Appellate Authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information."

5. In case you are not satisfied with the reply, you may appeal to Shri. B.S. Shinde, Traffic Manager and the First Appellate Authority, Traffic Department, Mumbai Port Authority, 1st Floor, Port Bhavan, Shoorji Vallabhdas Road, Ballard Estate, Mumbai - 400 001 against the same. His email ID and contact number is tm@mumbaiport.gov.in and 022-66564051. The period within which appeal could be preferred is 30 days from the date of this communication.
