Sub : **Ban on Fishing from 01.06.2024 to 31.07.2024**
(both days inclusive) (61 days)

Commissioner of Fisheries, Maharashtra vide order dated 14.05.2024 has imposed a fishing ban on motorized and mechanized fishing vessels in the territorial waters of Maharashtra from 01st June 2024 to 31st July 2024 (both days inclusive) for conservation and effective management of fishery resources and also for safety reasons.

In the above order, it has also been informed that the Government of India, Ministry of Fisheries, Animal Husbandry, Dairying (Department of Fisheries) by order dated 22.02.2024, has informed that the President of India is pleased to impose a uniform ban on fishing vessels in the Indian Exclusive Economic Zone (EEZ) beyond territorial waters on West Coast (including Gujarat, Daman & Diu, Karnataka, Goa, Maharashtra, Kerala, Tamil Nadu and Lakshadweep Islands) as per period mentioned below for conservation and effective management of fishery resources and also for sea safety reasons.

For the West Coast – from 01.06.2024 to 31.07.2024 (both days inclusive - 61 days)

2. Copy of order dated 14.05.2024 is enclosed for perusal.
3. In view of the above, it is requested to inform all your members that they shall observe the fishing ban strictly from **01.06.2024 to 31.07.2024 (both days inclusive)**. It may be also noted by your members that landing of fish catch in MbPA's fishing harbours, namely at Sassoon Dock and New Fish Jetty (Bhaucha Dhakka) will strictly not be allowed during the above ban period i.e. from **01.06.2024 to 31.07.2024 (both days inclusive)**. The members further be informed that no request for landing of fish catch during the ban period i.e. from **01.06.2024 to 31.07.2024 (both days inclusive)** shall be accepted on the plea that the boats have gone into the sea prior to 01.06.2024.
