In exercise of the power conferred under sub-section (1) of section 27 of the Major Port Authorities Act, 2021, the Board of Mumbai Port Authority *vide* Board Resolution No.36 has approved in its meeting dated 29th May 2024 the amendment in existing Clause 8.1.D under Chapter VIII – Miscellaneous charges of SOR. Accordingly, as required under Clause 4.7 of Tariff Policy, 2021, Board of Mumbai Port Authority hereby publishes amendment in Clause 8.1.D under Chapter VIII– Miscellaneous charges of SOR for information of all concerned. As per clause 4.8 of Tariff Policy, 2021, amendment shall come into effect after expiry of 30 days from the date of Notification in the *State Gazette* by Major Port Authority.

The existing clause 8.1.D - *Supply of Water by licensed agencies* of SOR shall be read as :

8.1.D. Supply of Water / Ice by Licensed agencies.-

Charges for supply of Water / Ice by licensed agencies will be levied at the rate of Rs. 20.43 per 1000 litres / per Ton respectively.
