Sub : Policy / SOP for Construction / Repairs of Vessels / Ships
at Lakri Bunder South / Powder Works Bunder.

For gainful utilization of the plots at Lakri Bunder South (LBS) and Powder Works Bunder (PWB) for repair / construction activities of ships / vessels, etc., a Policy / SOP for Construction / Repairs of Vessels / Ships activity was formulated and approved by the Board of Mumbai Port Authority.

2. Accordingly, the Trade was notified about the Policy / SOP for Construction / Repairs of Vessels / Ships at Lakri Bunder South / Powder Works Bunder vide Circular No. TM/B-10/07 of 2023-24 dated 04.05.2023 and modified Policy vide Circular No.TM/B-10/19 of 2024-25 dated 21.08.2024.

3. In terms of Sr. No. 04 of the Circular dated 21.08.2024, the Policy / SOP is reviewed with the approval of the Competent Authority. The revised Policy / SOP, alongwith the relevant Annexures, is enclosed herewith for strict compliance.

4. The Policy / SOP will be valid till 01.08.2025, subject to review at anytime for extension / updation / improvement or other action, as deemed necessary.
