With reference to your application dated 27.03.2025 under R.T.I. Act, 2005 it is to be informed that as per Ministry's guidelines under R.T.I. Act it is not required to create information or to interpret information or to solve problems raised by the applicant or to issue replies to hypothetical questions.

2. The reply on the information sought by you at Pt. No.1 to 5 of your subject application is as under:

Information sought by you vide your RTI Application dated 27.03.2025 had already been furnished to you vide this office reply dated 25.09.2024 to your earlier RTI Application dated 27.08.2024 seeking the same information.

As per CIC decision dated 25.06.2014 in case No. CIC/AD/A/2013/001326-SA (Ramesh Chand Jain V/s. Delhi Transport Corporation, GNCTD, Delhi), it was held that the citizen has no right to repeat the same or similar or slightly altered information request under RTI Act, 2005, for which he already got a response and such repetition of information request may be considered as reasonable ground for refusal under RTI Act.

Thus, information sought by you is repetitive and hence, it cannot be provided again.

3. If you are aggrieved by the above reply/decision, you may prefer an appeal within 30 days from receipt of this reply to the Appellate Authority i.e.
