Sub : Amendment to Clause 2.2 of Scale of Rates :
Lighterage charges during Non Monsoon period

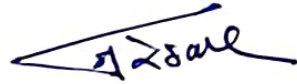
1. To further simplify the Anchorage – Lighterage billing, it is felt that the procedure of allocating percentage of total hours for Anchorage – Lighterage followed during Monsoon period be extended to Non- Monsoon period.
2. In view of above, the following amendment to the Clause 2.2 (c)(ii) is proposed :

Sl. No.	Existing	Proposed
c	(ii) During Non-Monsoon period (September to May) : Lighterage dues on Mother Vessels discharging/ receiving cargo – on foreign going vessels and coastal vessels, lighterage dues respectively at the rate of US \$ 0.0088 and Rs.0.2419 per GRT for a period of one hour or part thereof shall be levied from the expiry of three hours from the time the vessel is anchored or actual commencement of cargo operations whichever is earlier, till the completion of cargo at each anchorage point during September to May. Anchorage charges shall be levied excluding the above period.	(ii) During Non-Monsoon period (September to May) : Lighterage dues on Mother vessels discharging / receiving cargo – On foreign going vessels and coastal vessels, lighterage dues at the rate of US \$ 0.0089 and Rs. 0.2444 respectively per GRT for a period of one hour or part thereof shall be levied from the time it is anchored / occupies the place in stream / Port Lighterage Anchorage Area. Lighterage Charges will be levied @ 86% and Anchorage Charges will be levied @ 14% of the total stay of vessel at PLA / Stream.
