														3) The Ministry vide letter No. Pd-1 102U19 /207 PPP 1 e-328625 dated 29th September 2021 has communicated as under: " I am directed to refer to the Mumbai Port's letter No. GAD/ G/GM-SSG dated 1st March, 2021 & 7th July, 2021 on the subject mentioned above and to say that the Resoulation of the Board of Trustees of the Mumbai port on the subject appears to have been drawn after discussing the pros & cons of the modified proposal submitted by the Concessionaire regarding financiaing of the project. The proposal of getting the Debt:Equity ratio of 10:90 VETTED by a third party is also to ensure examination of arranging the equity by the Concessionaire. This can be carried out quickly too. Accordingly, the proposal of Mumbi Port Trust Board, including examination by a third party for capability of the onccenssionaire to arrange for the equity has been considered in this Ministry and the same has been agreed to".

On completion of Special Limited Tender Process, Letter of Award was issued to M/s BDO India LLP vide letter No. FA/SDP-T-96(2016) / 1520 dated 21.10.2021 by FA&CAO, with a request to convey acceptance of Letter of Award by 25.10.2021. Third Party Financial Institute BDO LLP have given Acceptance letter dated 25.10.2021 to the Letter of Award. The BDO officials had requested for all the documents availabel with MbPT regarding the project, which were submitted to BDO. Also, BDO had asked the Concessionaire to submit specific document which the Concessionaire has submitted to BDO directly.
														5. The Concessionaire has submitted the additional Bank Guarantee of Rs.35 Crores on 25.11.2021, issued by Cosmos Co-operative Bank. The Bank Guarantee has been confirmed by the issuing bank vide their letter dated 30.11.2021.
