Sub : Nomination of open area at MOD
for storage of General Cargo
under Section 3.3(A)(II)
of Chapter III of Scale of Rates.

In order to attract more cargo and in view of demand from MbPA Port Users, MbPA has been from time to time, through various Trade Circulars, nominating sheds/areas in Docks and Outlying areas for storage of Import cargoes under provisions of Section 3.3 (A) (II)/(V) of Chapter III of Scale of Rates (SOR).

2. Due to the increased demand from Trade regarding the storage facility for General Cargo at MOD open area, Open area at MOD has now been nominated for storage of General Cargo, subject to completion of Customs and MbPA formalities viz. payment of Port charges for the area and Customs Out of Charge for clearance of cargo, under the provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.

3. Storage permission of General Cargo would be granted subject to compliance of the following conditions:-

- a) The Importer/ CHB shall obtain the Out of Charge from Customs for the cargo and transport the same to the licensed area, on completion of Port and Customs formalities, including payment of Custom Duty and charges payable to the Port.
- b) The cargo shall be removed by the Importer/CHB at their own risk, responsibility and cost to the area permitted for storage of cargo.
- c) The storage of cargo at the permitted site shall be solely at the risk, cost and responsibility of the Importer/CHB.
- d) The Importer/CHB shall be required to vacate the permitted area, as and when required by the Port for which 15 days notice will be issued to the Importer/CHB.
- e) In case of any requirement of the permitted area by MbPA, the Importer/ CHB shall shift the cargo to any other location within 15 days as indicated by the Port, for which the shifting charges shall be borne by the Importer/CHB.
- f) The permission shall be initially for a period of one month and in case of further extension for permission of the storage area, the Importer/CHB should make an application and obtain permission from this office at least 7 days prior to completion of the 30th day on payment of advance payment.
- g) The rent shall be paid in advance.
- h) All possible care and safety precautions shall be taken by the Importer/CHB during the transportation of cargo, so that there is no nuisance or disturbance in other operations as well as the local environment and public health.
- i) All measures to mitigate and control of fugitive dust emission during subject cargo handling shall be taken.

4. It is requested to give wide publicity amongst your members to avail the above facility.
