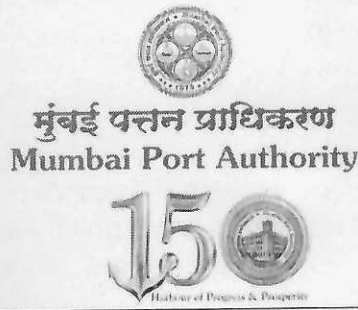

In pursuance of Section 54 and Section 55 of the Major Port Authorities (MPA) Act, 2021, the Central Government has constituted the **Adjudicatory Board for Major Ports (ABMP) on 13.08.2025**, vide Gazette Notification No. 3647 dated 13 August, 2025, comprising of a Presiding Officer and two Members as given below:

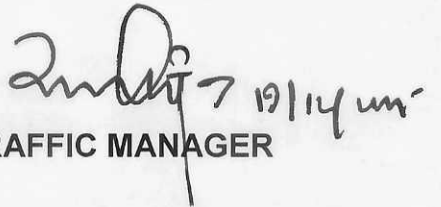
