Mumbai Port Authority Medical Department, invites applications for engagement of Experienced Specialists / Superspecialists as Part Time Visiting Consultants in Various Specialities at Mumbai Port Authority Hospital, on per visit basis.

1. Details of 26 Specialists/ Super Specialists as Part Time Visiting Consultants to be engaged on Contract basis are as follows:-

2. **Eligibility Criteria:**

3. Period of Engagement :-

- a. The initial period of engagement shall be 5 years, on the basis of performance review after every one year of engagement, for Continuation of the Part Time Visiting Consultant.
- b. The appointment of Experienced Medical and Surgical Specialists/ Superspecialists will be on Part Time Basis.

4. Remuneration:-

i) a) Visit Charges

- ii) If any Specialist is called on emergency basis apart from the routine visit, double the visit charges will be paid. If they perform any procedure/Surgery on emergency basis, only procedure/surgery charges will be paid by double rate.
- iii) The visit charges will be increase by 5% at the end of year on the basis of the Performance of Part Time Consultant taken by the Chief Medical based on the facilities utilised, patients attended/surgeries performed etc.
- iv) The Part Time Visiting Consultants on Contractual basis engaged shall not be entitled to any kind of allowance e.g. Dearness Allowance, House Rent Allowance, Transport Allowance, Transport Facility, Personal Staff, CGHS and Medical Reimbursement etc. Further they shall not entitled to any kind of Leave Accommodation, Medical Facilities in Mumbai Port Authority.

- v) TA/DA: The Part Time Visiting Consultants shall not be entitled to any TA/DA.
- vi) Tax Deduction at Source (TDS): TDS as admissible shall be deducted from the monthly remuneration of Part Time Visiting Consultant. A TDS certificate shall be issued by the Medical Department on demand.

5. Place of posting : The place of posting will be in Mumbai Port Authority Hospital as per the directives of the CMO / Sr. Dy. CMO (Specialist) Respective Faculty.

6.1 Procedure and Conditions for Applicants :-

- a) Interested applicants may apply offline in the format given on the website of MbPA.
- b) A candidate can apply for engagement only once during a financial year. The applicant who do not fulfill the eligibility criteria, their applications shall not be considered.
- c) The applications received shall be scrutinized and candidates will be shortlisted in the light of their qualification, experience and other details provided in the application form. Mere fulfillment of qualification or shortlisting shall not confer any right to be engaged as Part Time Visiting Consultant. He/She may be called for interview if required, before selection.
- d) The selected applicant has to produce original relevant documents at the time of joining.

6.2 Working hours and attendance:

The part Time Visiting Consultant will attend the hospital as decided by the Chief Medical Officer/ Sr. Dy. Chief Medical Officers of the respective faculties. They should also attend to emergencies as and when required, at any time of the day and night, as requested by Mumbai Port Authority Hospital.

7. Other Conditions :

- (i) Only eligible applicants who fulfill the criteria of essential qualification, experience, etc. shall apply.
- (vi) Conflict of Interest: The Part Time Visiting Consultant shall be expected to conduct themselves in accordance with the rules and regulations of MbPA. He/ She will be expected to demonstrate high moral character, integrity, secrecy of office and dedication to work while discharging his/her duties. In case the services of the Part Time Visiting Consultant are not found satisfactory or found in conflict with the interest of MbPA, his/her services can be terminated forthwith.

8. Use Name, Emblem or Official Seal of MbPA:-

Individual Part Time Visiting Consultant shall not represent themselves or otherwise make public with the intent to make a commercial advantage of the engagement with MbPA. The Part Time Visiting Consultant shall not, in any manner, whatsoever, use the name, emblem or official seal of MbPA, or any abbreviation of the name of MbPA in connection with his/her business or otherwise

without the prior permission of MbPA.

9. Relaxation : There will be no relaxation in any qualification.

10. Termination :

10.1 Engagement contract of Part Time Visiting Consultant may be terminated at any time by MbPA without assigning any reason thereof, by giving a notice of one month or after recovering proportionate remuneration in lieu of the notice. Part Time Visiting Consultant shall disengage themselves from MbPA, only after giving a notice of one month to MbPA.

10.2 MbPA may terminate the engagement forthwith **without** prior notice of one month in following conditions:-

- (i) The Part Time Visiting Consultant is unable to address the assigned work;
- (ii) Quality of the work is not to the satisfaction of Department/ Speciality;
- (iii) The Part Time Visiting Consultant is found lacking in honesty and integrity and not punctual in his work;

11. Right of the MbPA:-

MbPA has right to cancel the advertisement, and not go for engagement of Part Time Visiting Consultant, at any stage. It may accept or reject any or all applications without giving any reason therefore, whatsoever.

12 General instructions:

- (i) Mumbai Port Authority (MbPA) does not assume any responsibility for the candidates not being able to submit their applications within the last date whatsoever.
- (ii) Self- attested copies of documents/ certificates relating to Qualification/Experience etc. will have to be submitted along with the application and candidates shall produce the original certificate(s) for verification at the time of interview. The list of Documents are as given below:-
 - a) MBBS Degree Certificate
 - b) MMC Registration (updated)
 - c) Post Graduation Degree/Super Speciality Certificate
 - d) Experience Certificate
- (iii) Candidates serving in Government/ Semi Government, Public Sector Undertakings/ Autonomous Bodies will be required to submit "No Objection Certificate" from their employer at the time of application, failing which their candidature may not be considered.
- (iv) Decisions of the Mumbai Port Authority in all matters regarding eligibility, shortlisting and engagement shall be final and binding on all candidates. No representation or correspondence will be entertained by the Mumbai Port Authority in this regard.


13. How to apply:
