Sub : **Monsoon Fishing Ban from 01.06.2026 to 15.08.2026 (both days inclusive) (76 days)**

Ref : 1) This office letter No. TM/B/10A-05/III/285 dated 26.05.2026.
2) Order dt. 01.07.2026 of the Commissioner of Fisheries,
Maharashtra State.

Vide letter 1st cited, it was requested to inform all your members that they shall observe fishing ban strictly from **01.06.2026 to 31.07.2026 (both days inclusive-61 days)** and that landing of fish catch in MbPA's fishing harbours, namely at Sassoon Dock and New Fish Jetty (Bhaucha Dhakka) will strictly not be allowed during the above ban period i.e. from **01.06.2026 to 31.07.2026 (both days inclusive)**.

2. Now, vide 2nd cited, the Commissioner of Fisheries, Maharashtra State has informed that monsoon fishing ban on motorized and mechanized fishing vessels in the territorial waters of Maharashtra is from 01st June 2026 to 15th August 2026 (both days inclusive - 76 days) for conservation and effective management of fishery resources and also for safety reasons.

3. Copy of order dt. 01.07.2026 of the Govt. of Maharashtra is enclosed for reference.

4. In view of the above, it is requested to inform all your members that they shall observe the fishing ban strictly from **01.06.2026 to 15.08.2026 (both days inclusive-76 days)**. It may also be noted by your members that landing of fish catch in MbPA's fishing harbours, namely at Sassoon Dock and New Fish Jetty (Bhaucha Dhakka) will strictly not be allowed during the above ban period i.e. from **01.06.2026 to 15.08.2026 (both days inclusive)**.

5. Kindly ensure strict compliance of the above.

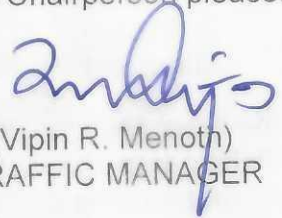
