By referred Circular dated 12.05.2022, an area admeasuring 1800 sq. mtrs. near Brown Gate, Indira Dock was notified for storage of import Calcite Chips under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.

- By referred Circular dated 21.03.2018, Temporary Sheds A, B and C (area admeasuring 12,000 sq. mtrs. approx.) at MOD were notified for storage of import Gypsum under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.
- By referred Circular dated 26.02.2019, Temporary Sheds 'A', 'B' and 'C' 3. at MOD Open Yard (area admeasuring 12000 sq. mtrs. approximately) were nominated for storage of MOP cleared from Docks / Bunders, in addition to pulses, Gypsum and Silica Sand (Temp Shed 'C') on recovery of charges under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.

- 6. By referred Circular dated 05.04.2021, Temporary Shed 'A' at MOD Open yard was nominated for storage of Ammonium Sulphate under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates, in addition to pulses and Gypsum.
- 7. In view of demand of the trade, Temporary Sheds 'A', 'B' and 'C' at MOD open yard is notified for storage of Calcite Chips cleared from Docks/Bunders, for a period of 60 days on recovery of charges under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates. The abovesaid cargo will attract demurrage at rates specified in Section 3.1(B) of Chapter III of the Scale of Rates (SOR) from 61 st day onwards. For the purpose of levy of demurrage 61st day of storage of above cargo will be treated s day number one.
