With reference to your subject RTI application referred above the information sought by you under para 4 (iii) is furnished as follows:

a) Letters dated 11.03.2014, 06.05.2014, 20.02.2014, 27.01.2015, 16.04.2019, 27.01.2017, 04.03.2020 and 05.03.2022 are not available in this office record

b) Letter dated 05.03.2022 is not available in this office record.

c) The system generated DARS statement for the period 01.05.2004 to 01.06.2022 can be provided on payment of the charges (46 pages). The amount lying in MD account is Rs. 50788.93.

d) The question asked is a hypothetical question, hence information sought by you cannot be furnished in terms of RTI Act 2005. (What is Not information) under RTI Act 2005. A Citizen can seek only information, which is available with the Public Authority in Material form leaving no provision to seek clarification by raising queries. It is not open to an applicant to ask, in the guise of seeking information, questions to the Public authorities about the nature and quality of their action. Further it may be noted that the public authority is not bound to answer queries like why and what and under what circumstances to an applicant. (CIC decision dated 10.05.07. K Anand Kini V. Canara Bank)

2. The charges amounting to Rs. 92/- (Rs.
