Sub: Concessional rates for demurrage on

export of agricultural products.

Ref: Circular No. TM/D/4-3/28 dated 13.03.2014

Vide circular dated 13.03.2014 referred to above, concessional rates for demurrage on export of agricultural products were re-introduced as under :

- i) Rs.13/- per tonne per day from 1st to 20th day as against Rs.48.75 per tonne per day;
- ii) Rs.33/- per tonne per day from 21st to 40th day as against Rs.73.10 per tonne per day; and
- iii) Rs.78/- per tonne per day from 41st day onwards as against Rs.97.50 per tonne per day.

The above concessional rates were effective from 08.03.2014 for one year, subject to review after notification of revised SOR by TAMP.

- 2. The Tariff Authority for Major Ports (TAMP) vide Notification dated 19.01.2015 have increased tariff of cargo related charges including demurrage by 23%, effective from 18.02.2015.
- 3. The Board has now accorded sanction to the levy of concessional demurrage on export of agri-products as under:
 - a. Rs.16/- per tonne per day or part thereof from 1st to 20th day as against Rs.59.96 per tonne per day or part thereof;
 - b. Rs.41/- per tonne per day or part thereof from 21st to 40th day as against Rs.89.91 per tonne per day or part thereof; and
 - c. Rs.96/- per tonne per day or part thereof from 41st day onwards as against Rs.119.93 per tonne per day or part thereof

The difference between the rates as per SOR and the proposed rates shall be treated as remitted.

- 4. Subject concessional rates on demurrage for export of agri-products shall be applicable from 18.02.2015 for a period of one year.
- 5. All exporters of agricultural commodities and their Associations are requested to avail this facility and route their exports of agri-products through Mumbai Port.
- 6. You are requested to give wide publicity amongst all your members to avail the benefits of the aforesaid concession.
