Offshore Container Terminal (OCT) for handling  
of containers at MbPT.  
- Handling of Ro-Ro vessels.**

M/s. Indira Container Terminal Pvt. Ltd. (ICTPL) have been permitted to handle Ro-Ro vessels at Offshore Container Terminal (OCT) Berth for a period of one year from the date of operation on trial basis. They have commenced handling of Ro-Ro vessels w.e.f. 20<sup>th</sup> July 2015.

2. Berthing of vessel at OCT berth will be declared by M/s. ICTPL at least 15 days in advance. In this regard, this is to inform that the concerned vessel agents will be required to pay berth hire charges to the ICTPL for the Ro-Ro vessels handled at OCT berth and submit the receipt of payment in the office of Sr. Dy. Traffic Manager, Indira Dock before allotment of berth. Similarly, the Importers / Exporters will have to pay wharfage charges to ICTPL on the import / export cargo handled from Ro-Ro vessels at OCT berth. Importers / Exporters will be required to obtain the necessary endorsement of payment of wharfage charges on EDI Bill of Entry / Shipping Bill.
