With reference to your subject RTI application referred above the information sought by you under para 4 (iii) is furnished as follows:

- a) Letters dated 15.07.2011, 07.09.2021, 08.10.2021 and 15.10.2021 are not available in this office record. For letter dated 05.03.2022 no action is yet finalized.
- b) Letter dated 15.10.2021 is not available in this office record. For letter dated 05.03.2022 the information is furnished as below.
 - i) The system generated statement of month to month billed arrears of storage code 41413821 for the period 01.05.2004 to 01.06.2022 can be provided on payment of the charges (41 pages).
 - ii) copies of casual mema issued for the period 01.05.2011 to 31.05.2019 can be provided on payment of charges (44 pages).
 - iii) the details of area of storage are covered in the casual mema mentioned at ii above.
 - iv) Details of month wise payment received from from Mohammed Essak Haji Abbas against the subject code from 01.05.2011 to 31.05.2019 can be provided on payment of the charges (18 pages).
 - v) an amount of Rs. 10101.38 is in MD account as on 22.06.2022 (8 pages).
 - vi) Details of SD
 - vii) No renewal of FDR.
- c) No such record is available in this office.
- d) In view of c above Names cannot be furnished.
- e) Please see b (i) above.
- f) The question asked is a hypothetical question, hence information sought by you cannot be furnished in terms of RTI Act 2005. (What is Not information) under RTI Act 2005. A Citizen can seek only information, which is available with the Public Authority in Material form leaving no provision to seek clarification by raising queries. It is not open to an applicant to ask, in the guise of seeking information, questions to the Public authorities about the nature and quality of their action. Further

it may be noted that the public authority is not bound to answer queries like why and what and under what circumstances to an applicant. (CIC decision dated 10.05.07. K Anand Kini V. Canara Bank)
