CORRIGENDUM

To Trade Circular No. TM/S/ 11-3/ 15 of 2011-12
dated 4TH October, 2014

**Sub : Advance application for registration of Stevedores
in Mumbai Port Trust.**

Pursuant to the requests / feedback received from various Port Users, following clarifications and / corrigendum to the above referred Trade Circular may please be noted :

- (i) Due to a number of holidays on account of festival of Diwali, the last date for submission of advance application for registration of Stevedores in Mumbai Port Trust is extended till **7th November, 2014.**
- (ii) In terms of Clause 4.3 (e) of the Policy notified in the Maharashtra Government Gazette Notification No. GAD/G/REG / 8744 dated 27.12.2012 and 03.01.2013, no license to work as a stevedore shall be granted unless the applicant produces a Bank Guarantee of Rs. 5 lakhs so as to meet any contingency. Since at present only advance applications are invited, the Bank Guarantee of Rs. 5 Lakhs is not required to be submitted at this stage. The short-listed applicants will be required to submit the Bank Guarantee of Rs. 5 lakhs in the prescribed form, within one week of issuance of written intimation from MbPT. The format of the Bank Guarantee will be uploaded on MbPT's homepage in due course.
- (iii) With regard to Clause 6 (ii) of the Policy notified in the Maharashtra Government Gazette Notification No. GAD/G/REG / 8744 dated 27.12.2012 and 03.01.2013, this is to clarify that at present only advance applications are invited. The short-listed applicants will be required to submit the prescribed License Fee as well as EMD, in the form of DD/ Pay Order issued by any Nationalized / Scheduled Bank in favour of **"The Board of Trustees of the Port of Mumbai"**, payable at Mumbai, within one week of issuance of written intimation from MbPT.
- (iv) Application alongwith requisite documents as prescribed in the Policy notified in the Gazette Notifications dated 27.12.2012 and 03.01.2013, is required to be submitted in the Form A on the Company's letterhead, duly signed by the Authorized Signatory of the Company.

- (v) With regard to Point No. 4 of application Form A, the applicants are required to submit certified copy of the contract with Vessel Owners / Charterer of Ships/ Owner of Cargo for Stevedoring the vessels calling at Mumbai Port.
- (vi) With regard to Point No. 9 of application Form A, applicants are required to submit a Certificate of no outstanding dues, to be issued by Sr. Dy. Traffic Manager (OBL) along with the application Form A.
- (vii) The application Form A duly filled up along with requisite documents may be submitted in the office of **Sr. Dy. Traffic Manager(OBL), 3rd floor, Ambedkar Bhavan, P. D'Mello Road, Mumbai – 400 001, on all working days during office hours between 10.30 a.m. to 5.30 p.m. on or before 7th November, 2014.**
