### NOTIFICATION No. 08/2015

Whereas the area of Offshore Container Terminal inside Mumbai Port, Mumbai Port Trust is under in its final stage of completion and shall be declared as the Customs Area.

And whereas M/s. Mumbai Port Trust, the custodian u/s 45 of Custom Act 1962, has proposed to utilise the completed part of the above mentioned terminal for RO-RO operations exclusively, as an interim arrangement for 01 year.

Now, In exercise of the powers conferred on me under Section 8(a) of the Customs Act, 1962, I, B. Bhattacharya, Pr. Commissioner of Customs (General), New Customs House, Ballard Estate, Mumbai hereby notify the completed area of Offshore Container Terminal as described in the schedule-I below, built by M/s. Mumbai Port Trust and M/s. Indira Container Terminal Private Limited as a place for unloading of imported vehicles and for loading of export vehicles subject to the strict observance of the Provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or Principal Commissioner of Customs, New Customs House, Ballard Estate, Mumbai, from time to time.

Further, under Section 10 of the Customs Act, 1962, I, B. Bhattacharya, Pr. Commissioner of Customs (General) hereby specify the area described in Schedule-I below as the 'Boarding Station' for purpose of boarding of, or disembarkation from, RO-RO vessels by officers of customs.
