Sub: Extension of concessional charges for storage of empty containers at designated yards of Mumbai Port

Vide the above referred circular, concessional charges applicable for storage of empty containers at designated areas and other CFSs areas were informed and Port Users were requested to avail of the facilities. These concessional charges effective from 11.09.2006 and valid up to10.03.2007 were to be reviewed.

Levy of concessional charges for storage of empty containers has been reviewed and will be continued for a further period of one year effective from 11.03.2007.

The concessional charges to be levied will be as under:

<ul> <li>ii) Container destuffed &amp; stored in the Container Freight Stations.</li> <li>(concessional charges to be recovered from the 4<sup>th</sup> day from date of destuffing till date of removal or stuffing of container. For first three days charges will be as per Scale of Rates)</li> </ul>	\$0.5	\$1.0	\$1.5

These concessional rates shall not apply for containers handled in Docks proper.

These concessional rates will remain valid till 10.03.2008 and reviewed thereafter. You are requested to give wide publicity amongst your members of the aforesaid facilities offered at concessional rate for storage of empty containers and handle more containers though Mumbai Port.
