- viii. Report for water taste carried out by Port Health Organization.
- ix. Report of Bacteriological Test carried out by the Muncipal Analyst, B.M.C. Mumbai.
- c. After processing case permission will be issued within 6 working days from the date of submission of the application in addition to insure compliance with the following terms and condition.
 - 1) Permission is granted to the firm to supply fresh water in Mumbai Harbour through their Barge.
 - 2) The Firm have to obtain permission for the use of Bunder premises from the Traffic Manager, Mb.P.T.
 - 3) The charges levied for supply of fresh water to vessel shall not exceed the rate prescribed by the ports scale of Rates or so specified by TAMP.
 - 4) Every time the Firm have to load their barge with fresh water and the same should be duly certified by the BMC for potability and should be as per the norm set by the Port Health Officer.
 - 5) Unless otherwise specified in writing by the Master/Agent of the vessel that the fresh water in required for any other purposes other than drinking . The Firm to supply only potable water duly approved and certified by BMC and Port Health Officer.
 - 6) The firm shall be liable for damages to Port Trust property/crafts and settle the bills promptly for any damages caused to the port Trust properly /crafts etc. However Mumbai Port Trust will not be responsible for any damages to firm's barge.
 - 7) The firm have to obtain Pass Pilot /Plying permission from Deputy Conservator and permission to supply water will be valid subject to renewal of pass Pilot/ Plying permission.
 - 8) If at any time it is found that the firm is violating any of the above conditions or licensing regulations of the barge. The Permission to supply Fresh water will be withdrawn.
 - Unless revoked or suspended, this permission is valid for only 1 year. There after it may be renewed at the sole discretion of the Deputy Conservator.
 - 10) If at any time in future, Mb.P.T. as a policy decide to withdraw, permission to Private parties to supply fresh water to ships in Mumbai Harbour, the permission granted to the firm will be withdrawn after giving notice.
