Attention of the public is invited by The Board of Trustees of the Port of Mumbai (hereinafter referred to as the "Board") to the Notice appearing in the issue of the newspaper "The Free Press Journal" dated 30/08/2018 and in the issue of the Marathi Newspaper "Nav Shakti" dated 30/08/2018 issued by J. M. Financial Asset Reconstruction Company Ltd., under the provisions of the SARFAESI Act in respect of the property described below.

The Board states that by Notice dated 27/09/2012 the interest of the lessees i.e. Shubh Hospitality Private Limited, in the Plot and the building standing thereon known as "Shelley's Estate" on RR No.1245, Cadastral Survey No. 10/384, 30, P. J. Ramchandani Marg (Opposite Radio Club), Strand Road, Colaba, Mumbai 400 005, has been terminated with effect from 01/01/2013. The Board further states that pursuant to the aforesaid notice the Board has filed eviction proceedings, proceedings for recovery of arrears and damages before the Estate Officer vide EO/E/ (135)(135A)(135B) of 2013 against Shubh Hospitality Private Limited, Bank of India, J. M. Financial Asset Reconstruction Company Ltd. The Board further states that the Estate Officer has issued a show cause notice dated 18/2/2018 against Shubh Hospitality Private Limited, Bank of India, J. M. Financial Asset Reconstruction Company Ltd under Section 4 of the Public Premises (Eviction of Unauthorised Occupants) Act, 1971. The said proceedings are pending before the Estate Officer. The Board further states that the Hon'ble High Court of Bombay on 25/3/2013 in Writ Petition no. 502/2013 filed by the Board against the Shubh Hospitality Private Limited, Bank of India, J. M. Financial Asset Reconstruction Company Ltd has held that: "The auction purchaser, if any would acquire the property, subject to the rights, if any, of the Petitioners (The Board of Trustees of the Port of Mumbai)"

In view of the above the said lessees, sub-lessees, mortgagees and all persons claiming by under or through them are unauthorized occupants within the meaning of that expression as defined under Section 2(g) of the Public Premises (Eviction of Unauthorised Occupants) Act, 1971. In view thereof, the proposed purported E-Auction sale of the property described herein below is illegal.

The proposed auction purchasers are hereby warned that they are liable to be evicted in the pending proceedings before the Estate Officer against the said Lessees i.e. Shubh Hospitality Private Limited, Bank of India and J. M. Financial Asset Reconstruction Company Ltd. Hence, person/s dealing with the said property shall do so at their own risk. The Auction purchasers are warned the Board shall under no circumstances transfer/assign the premises in the name of the prospective purchaser/s as the proposed sale / assignment itself is ab-initio illegal.
